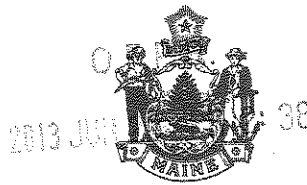

RE: **Priorities for bills on Appropriations Table**

DATE: June 19, 2013

Pursuant to Joint Rule 314(7), we are reporting our committee's priorities for final passage of bills reported out of our committee based on the list of bills and subsequent fiscal notes provided to us by OFPR.

The chairs reviewed the list of bills that are on or headed for the appropriations table with committee members and adopted the following prioritization. Please note that every bill is the result of careful deliberation and of high priority for the committee. Nonetheless, the highest priorities for General Fund appropriations are (in order of importance) as follows:

LD	Title and Priority	fiscal impact FY14	fiscal impact FY13
541	A/A to Amend the Laws Governing Complimentary Hunting, Trapping and Fishing – <i>highest priority</i>	\$25,610	\$34,146
932	A/A to Promote Fishing by Youth – <i>second highest priority</i>	\$48,750	\$65,000
1435	A/A to Amend Certain Provisions of the Fish and Wildlife Laws – <i>priority number three</i>	\$48,750	\$65,000

Please note, that the committee strongly urges the passage of all other provisions contained in LD 1435 even if the fiscal impact for nonresident junior hunting license permits in Sec. 9 of the amendment cannot be fully funded as requested. However, should this measure pass, the ease and convenience of its consolidated one-size-fits-all hunting license is expected to increase nonresident junior hunting registrations, generating additional General Fund revenue.

The committee views the following bills as revenue neutral, and asks that they pass without question or concern for reasons stated below.

<b>LD</b>	<b>Rationale</b>
200	Uses carrying account (already funded)
172	Bill removes sunset for initiative established w/out fiscal impact 3 yrs. ago (already funded)
738	Proceeds of the new moose hunting permit lottery system will be allocated to youth conservation education programs and any remainder will be allocated to the Moose Research and Management Fund. If needed, revenue from the lottery system could be applied to administrative costs first (to eliminate the impact to the General Fund), followed by youth conservation education programs and the Moose Research and Management Fund (in that order).
1263	To make this initiative self-sustaining, the committee recommends that the increased revenue dedicated to snowmobile trail fund be used to absorb (offset) the impact to General and the State and Local Government Funds caused by the bill's diesel fuel sales tax exemption.
